### Exhibition Overview and Selection

The 8<sup>th</sup> Clean Energy Ministerial (CEM8) and 2<sup>nd</sup> Mission Innovation Ministerial (MI-2) will feature a Clean Energy Technology Exhibition with companies and organizations from around the world exhibiting their innovative clean energy technologies, products and business models. The exhibition will cover six related sectors: renewable energy, energy-efficient technologies and facilities, energy storage technologies and facilities, digital energy and smart grid, electric vehicles and related technologies, and finance and business model innovation.

The acceptance of exhibitor applications will be based on relative merit and adherence to the following criteria:

- **Topicality:** Provides an example of innovation related to at least one of the six innovation areas identified above.
- **Impact:** The innovation's potential for impact and scalability to accelerate global clean energy deployment or low-carbon development.
- **Representative:** The exhibits can represent the leading technology in the relevant area.
- **Intelligibility:** Proposals, even of a complex or technical nature, must articulate their value in easy to understand terms that are comprehensible to lay audiences.
- **Completeness of Application:** Application includes all required information and provides an accurate and thorough description of the technology to be presented.
- **Sector and Geographic Diversity:** Diversity in exhibitors among the six technology sectors as well as geographic/country distribution.

If an applicant withdraws his application, for whatever reason, before he receives either a rejection or confirmation of his application, any participation fee paid will be forfeited.

The booth will be allocated in accordance with marketing criteria. No change of booth location is allowed once it has been assigned & informed. The Organizers have the sole and absolute discretion in allotting the area in the Exhibition Venue for the positioning or construction of booths and determining the location of such booths. All decisions to such effect shall be final and no request for changes will be entertained.

### 8. Booth construction
